Motivational interviewing is a collaborative approach designed to aid clients in strengthening their motivation and commitment to behavioral change. Initially developed for smoking cessation and substance abuse treatment, motivational interviewing has 40 years of research supporting its use with a wide range of clinical treatment needs, including the needs of clients involved with forensic and legal systems. Using this evidence-based approach promotes successful rehabilitation and reentry by drawing on clients' values, goals, and strengths and equips providers with the tools necessary to enhance therapeutic engagement.

In this two-day workshop, participants will explore and practice the application of motivational interviewing to a range of clients involved with forensic and legal system settings. Key concepts will include strategies for identifying important client values, orienting the client to conversations about change, building a treatment plan, and identifying change and commitment talk from clients in forensic systems. Participants will review and discuss barriers to facilitating client motivation and change in forensic settings, emphasizing the unique challenges we face in working with clients who are mandated to treatment and may have limited willingness to engage in the change process. This will provide opportunities to identify and troubleshoot common problems in clinical practice with forensic clients. Through demonstration and live practice opportunities, participants can apply a variety of motivational interviewing techniques to differing client populations and clinical presentations in forensic work.

Dr. Jill D. Stinson is a licensed clinical psychologist and the Director of Clinical Training in the Department of Psychology at East Tennessee State University. She received her dual doctorate in Clinical Psychology and Psychology, Policy, and Law from the University of Arizona prior to serving as the Sex Offender Treatment Coordinator at Fulton State Hospital with the Missouri Department of Mental Health. Her research focuses on serious mental illness, personality disorders, self-regulatory problems, and histories of early childhood maltreatment in persons who have committed violent and sexual offenses, as well as issues related to community re-entry, stigma, and suicidality in justice-involved populations. Dr. Stinson has authored three books related to etiology and treatment of sexual offending and motivation to engage in therapy. She serves as an Associate Editor for Sexual Abuse and is the Secretary of the Board of the Council of University Directors of Clinical Psychology.
